- PJW Area XII Medals will be awarded to the top 3 finishers at each weight class. The top 2 wrestlers will represent Area XII in the PJW Junior High State Championships at the 1<sup>st</sup> Summit Arena in Johnstown, PA on Feb 28 -March 2, 2025.

## AREA XII PJW CHAMPIONSHIP



### **PJW Rules**

- 1) Wrestler must reside in AREA XII comprised of Bradford, Lackawanna, Luzerne, Pike, Susquehanna, Wayne, and Wyoming Counties. Also including the Berwick School District area of Columbia County.
- 2) Wrestler may only submit one entry and may only wrestle one weight class and division.
- 3) JH wrestlers must be in grade 7, 8, or 9 with PIAA defined Jr. High eligibility.
- 4) No wrestler with Varsity or Jr. Varsity experience will be permitted.
- 5) An 11 or 12 year old on a Jr. High roster may choose only 1 PJW tournament series (Youth or Jr. High).
- 6) Refer to <http://www.piaa.org/schools/eligibility/default.aspx> for PIAA defined eligibility.
- 7) No weight changes will be permitted after entry form has been submitted online.
- 8) *Wrestlers not making weight at weigh-ins will forfeit their entry without refund.*
- 9) *Proof of residency and age of wrestlers must be provided if requested by a PJW Official.*
- 10) JH entrants must be willing to represent Area XII at the PJW Jr. High State Tournament.
- 11) *Advancing wrestlers will be required to pay a non-refundable \$50.00 gear package fee on the day of the area tournament.* The package includes an Area XII singlet and shirt that must be worn at the state tournament. Wrestlers will keep their shirt and singlet.
- 12) *Wrestlers must provide a copy of their birth certificate to the Area XII Chairman prior to the state tournament.*
- 13) Championship bout times are 1:30 ~ 1:30 ~ 1:30. Consolation bouts are 1 ~ 1:30 ~ 1:30. PIAA OT rules apply.
- 14) A singlet must be worn for weigh-ins. There will be separate weigh in rooms for girls and boys.
- 15) Head gear is required. Shoe laces must be secured. PIAA hair, gear and uniform rules apply. A suitable undergarment is required. *A mouth guard is required to cover braces. Mouth guards must be presented at weigh-ins and approved by the official in charge.* Mouth guards must have a top and a bottom.
- 16) Seeding will be determined by tournament committee. Accolade information is critical to weight class seeding. Previous year PJW state tournament placement is the highest recognized accolade. All decisions are final.
- 17) Full double elimination format will be used. True second bouts will be wrestled when necessary.
- 18) Failure to comply with any PJW or PIAA rule will result in disciplinary action and/or forfeiture of participation.
